Admissions Seekers under **Kashmiri Migrants Category** and **Tuition Fee Waiver (TFW) Quota** in **B.E./B.Tech./ B.Pharma** in Govt./ Govt. Aided institutes/ Universities Department /Private Institutes in the State of Haryana for the Session 2011-12.

As per AICTE, minimum eligibility qualification (as mentioned in respective admission brochures) has been relaxed to 45% (40% in case of SC category) in B.E./B.Tech./ B.Pharma/BHM&CT in the State of Haryana for the Session 2011-12.

Kashmiri Migrants (KM):

The candidates who could not apply for B.E./B.Tech./ B.Pharma courses under **Kashmiri Migrants Category**, are required to submit the attested copy of the migration certificate duly signed by the competent authority or Relief commissioner and attested copy of marksheet of qualifying examination along with the application form. The admission shall be made on the basis of merit in the qualifying examination (as mentioned in respective brochures), subject to fulfilling the eligibility criteria.

Only Kashmiri Migrants who have migration certificate and have passed there qualifying examination on the last date of submission of application form are eligible.

Tuition Fee Waiver (TFW) candidates:

Criteria:

- Sons and daughters of parent having annual income of less than Rs. 2.50 lakhs from all sources shall only be eligible for seats under this scheme.
- Only Haryana Resident candidates may apply for these seats.

The candidates who could not apply for B.E./B.Tech./ B.Pharma courses under Tuition Fee Waiver (TFW) Quota, shall submit the Application Form along with attested copy of Parents Income Certificate from all sources from the organization where he and she is working or Affidavit of Income on stamp paper from Notary.

Candidate who have taken AIEEE (in case of B.E./B.Tech. course) and online entrance test-OLET B.Pharmacy (in case of B.Pharmacy) are eligible under TFW category.
